Work items include terminal building reroofing with mansard alterations and electrical improvements.

Each proposal must be accompanied by a Bid Security pursuant to Chapter 1305 of the Ohio Revised Code, in the amount stated and payable to the order of the Owner. The Bid security shall be in the form of either a Bid Bond for the full amount of the bid or a certified check, cashier's check or letter of credit for an amount equal to ten percent (10%) of the bid. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Bids may be held by the Fairfield County Airport Authority for a period not to exceed 60 days from the date of the bid opening for the purpose of evaluating bids prior to award of contract.

The right is reserved, as the Airport Authority may require, to reject any and all bids and to waive any informality or irregularity in the bids received.

Bidders must comply with the Ohio Prevailing Wage Rates on this Public Improvement in Fairfield County, Ohio as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration.

All Contractors and Subcontractors involved with the project will, to the extent practicable, use Ohio products, materials, services, and labor in the implementation of their project.
